Located in Bas-Saint-Laurent (Quebec), the company ROTO-MSB, which manufactures plastic parts by rotational molding and proposes subcontracting services, has just increased its production capacity with the purchase of a new oven. The addition of state-of-the-art equipment allows the company to be very competitive in the market. Rotational molding has several advantages: a low cost compared to injection

molding; the manufacturing of large and small parts, simple or complex; several possible surface finishes; a very wide range of colors; control of wall thickness; and the possibility of additions (inserts, threads, engraving). (article in French)
