On 24 March 2022, the AFR Development Commission was held, in the presence of 30 industrial members of the AFR, hosted by the company ANVI in Burgundy. Several subjects were on the agenda, such as the launch of an e-learning training module dedicated to rotational moulding, the use of plastics from post-consumer recycling, the construction of a production planning software specific to rotational moulding, as well as the themes of the next AFR Master Classes and the project to construct a specific economic survey for the rotational moulding sector. Study on the Properties and Structure of Rotationally Moulded Linear Low-Density Polyethylene Filled with Quartz Flour



The objective of this study is to determine selected properties of thin-walled rotationally moulded composite parts. Linear low-density polyethylene (LLDPE) filled with quartz flour (QF, 5–35 wt.%) was tested. High-density polyethylene functionalized with maleic anhydride (HDPE-g-MA) was used as a compatibility agent. Polymer samples were prepared with and without the compatibility agent (2 wt.% in relation to the QF content).

France: Altur Investissement gets an equity stake in EMP Rotomoulage



Altur Investissement will acquire a stake in the French company EMP Rotomoulage, based in Dol-de-Bretagne, France. The operation is supported by BNP Paribas and Unexo, the company's historical investors. It allows William Digne, who bought the company in 2018, to take the majority of the capital. As specialist in rotational moulding products, EMP Rotomoulage manufactures more than 130,000 rotational moulded parts each year and processes more than 2,300 tonnes of polyethylene. In Chalon-sur-Saône, France, Métroplast, a manufacturer of waste containers, is investing €400,000. Supported by ADEME, the French Environment and Energy Management Agency, the project aims to increase the proportion of recycled plastic in production by the end of the year. In 2022, Métroplast plans to increase its turnover from 17 to 25 million euros after relocating part of its production, and thanks to a developing niche market. (Translated from French)
